The widespread political resistance to the government took several different ways. Such resistances may include legitimate or non-legitimate approaches, within or outside the Constitution, involving or not the representative political institutions. At the same time, these processes may pursue different objectives which include from civil disobedience up to the government ousting. This article examines the most common institutionalized ways of civil resistance to the government: the use of direct democracy to change the unpopular government's policies. Specifically, this article examines the use of referendum in Uruguay, since the transition to democracy in 1985 to date.

This article seeks to contribuye to the debate over citizenship in Latin America and to suggest some themes for further debate. After a brief review of the processes that influence the reconfigurations of citizenzship, we argue that the formal approach to the rights and duties of the citizen should be renovated and complemented with an anthropogical perspective. We also argue that the processes of globalization and societal change throw up new questions. Once these «transversal» themes have been discussed, we reflect on the principal «classic» dimensions of citizenship (civil, political and social rights) as well on the issue of the emergent ethnic citizenship.

VAN COTT, Donna Lee INDIGENOUS MOVEMENTS AND THEIR SUCCESSES: REPRESENTATION AND LEGAL RECOGNI-TION IN THE ANDES América Latina Hoy, 36, april 2004, pp. 141-159

During the last decade, indigenous movements in the Andean region have made impressive gains in political representation, notwithstanding the unfavorable context in which they operate. They did so by taking advantage of the conjuncture of institutional crisis and constitutional reform to link their demands to those of the political elite, which sought to strengthen the legitimacy of democratic institutions. As a result, the institutional context today is more favorable for new political movements wishing to participate in formal politics –particularly for indigenous movements–. Moreover, indigenous movements have taken advantage of the weakness of traditional parties and party systems to carve out a space for themselves as leaders of or partners in coalitions against neoliberal reform and corruption.
