

1. *STUDIA HISTORICA. HISTORIA ANTIGUA* is a journal published annually, manuscripts submitted for possible publication will be assessed by two external reviewers through the double blind system. The Editorial Board, respecting the intellectual freedom of the authors, will not modify the opinions they express, neither will it declare support for them.
2. The Editorial Board of *STUDIA HISTORICA. HISTORIA ANTIGUA* will consider unpublished manuscripts (which have not been published previously in any version and are not being submitted simultaneously for publication elsewhere), provided that they have a high level of quality and deal with aspects relating to the chronological period within the sphere of Ancient History. This may be done in several ways: by introducing new topics, using a different, more in-depth approach to a problem already recognized in historiography, contributing heretofore unknown information in relation to a specific historiographical matter, or the potential applications of a new or more refined methodology.
3. The original in Word Format (.doc) should be deposited in <https://revistas.usal.es/index.php/0213-2052/about/submissions#onlineSubmissions>. It should also be sent by e-mail to shha@usal.es. The submission of originals will be open throughout the year. The volume of the corresponding year will be closed at the Editorial Board meeting in May.
4. Articles should be no longer than 70,000 characters (white spaces included), including tables, diagrams, maps captions, notes and bibliography. Each text should be preceded by a page with the title of the study, name of author or authors, professional category, work center, full postal address, telephone number, e-mail, and ORCID.
5. All manuscripts must be accompanied by an abstract (1,000 characters, maximum) in the language of the manuscript, in Spanish, and in English. The title and key words must also be sent in these same languages for indexation purposes.
6. Footnotes should be numbered correlatively in Arabic numbers in superscript, preceding the diacritic sign, if any. All notes must be footnotes. Note calls will preferably be inserted at the end of the sentence. An excessive number of textual quotations should be avoided, and, in any case, if the quotation exceeds two lines it should be indented, without quotation marks. Moreover, author's comments in textual quotations should be placed between square brackets to distinguish them clearly from the text quoted.
7. The bibliographical references in the notes should follow the Chicago style of referencing (https://www.chicagomanualofstyle.org/tools_citationguide/citation-guide-1.html), with shortened notes and bibliography: Last name, short title, page number (without p. or pp.); n. for foot note, no. for number, col. for column. Griese, *Die Nutzung*, 198-204; Marcone, «L'evoluzione», 279-84; Gómez-Pantoja, «*Pastio agrestis*», 181-3.
8. All articles shall include a list with the bibliography used according to The Chicago Manual of Style:

 In case of works by two authors the names are separated by «and», if there are three «, and», four or more the first «*et al.*» is quoted. The journals will be quoted by the full name, without abbreviations. Quotes from authors and classic texts shall be made in accordance with the rules of the *Oxford Classical Dictionary*.
9. Arabic numerals should be used in numbering divisions and sub-divisions of the manuscript, without mixing them with roman numbers or letters. The tables, graphs and maps included in the paper should be correlatively numbered with Arabic numerals. Each table, graph or map should have a short title to identify it and its sources should be indicated.
10. The secretary's office of *STUDIA HISTORICA. HISTORIA ANTIGUA* will acknowledge receipt of manuscripts within a period of thirty working days after their reception, and the Editorial Board will decide on their publication in a maximum period of six months.
11. The authors will receive only one print proof. The Editorial Board requests that during the correction of proofs no major changes be made to the original text, since this may have repercussions on publishing costs. The authors commit themselves to correcting the proofs within a period of 15 days, counting from the day they are handed over to them.
12. *STUDIA HISTORICA. HISTORIA ANTIGUA* does not give the right to any payment. If someone wants to reproduce an item, in whole or in part, it is necessary to indicate its provenance.
